UTEC UPDATE

At the March UTEC committee meeting, new initial licensure admission to program requirements for graduate and undergraduate students were approved. These will apply to students entering Ohio State in the autumn semester 2014. The requirements will be a background check, a 3.0 GPA, a Disposition Form, and standardized assessment scores in Reading (ACT 21, SAT 490, Pearson NES 220, or GRE verbal 145), Mathematics (ACT 21, SAT 490, Pearson NES 220, or GRE quant 145) and Writing (ACT 21, SAT 490, Pearson NES 220, or GRE writing 3.5). Additional details will be forthcoming.
