## **FACULTY/STAFF SPOTLIGHT: DR. PHILLIP WARD**

Dr. Phillip Ward is a Professor of Kinesiology in the Department of Human Sciences. He teaches classes in physical education teacher education and spends part of each week in formal and informal contexts working with teachers on professional development to improve instruction in physical education. He is the lead investigator of the *Learning to Teach Physical Education Research Program*, found at:

being on the development of content knowledge for teaching physical education.

## **Data-driven Changes in the Physical Education Teacher Education Program**

In response to data from the edTPA, the physical education faculty members have made changes to prepare students to successfully complete the edTPA. Examples include: breaking tasks 1-3 into different elements, providing feedback, and allowing revisions. Faculty members are conducting studies designed to assess recent changes in the way they teach content knowledge to their students. ## **OAE UPDATE**

The State Standards Board met and has re-aligned adjusting the standard error of measure (SEM) for some of the OAE assessments, which took effect retroactively on June 1, 2014. The following tests will be adjusted by (-1): Middle Childhood Mathematics, Middle Childhood Science, and AYA Language Arts. The Middle Childhood Social Studies OAE will be adjusted by (-2) SEM. These adjustments will likely result in a higher pass rate for students.

## **LICENSURE UPDATES**

### **Attention Ohio Education Permanent Certificate and Licensure Holders**

All education licensure and certificate holders must update their licenses every five years. Beginning July 1, educators that have not had a background check within the last five years may be inactivated. ### **Licensure Application Processing**

Due to the high volume of licensure applications going through ODE's Secure Application For Enterprise (SAFE) account system, licensure approval may take longer than usual. The Office of Educator Preparation appreciates your patience as ODE works to process all licensure applications in a timely manner. Please advise your students that the SAFE system will auto decline licensure applications after 180 days, so it is best not to apply too early.

Please also make sure students are requesting correct reason codes for background checks. If students are in the schools, they must have the following codes: BCI&I code [3319.39B3](#) and FBI code [3319.39](#). Students with incorrect codes will have to complete the process again. Current prices at OSU Columbus Campus are: BCI&I- \$37.70; FBI-\$39.70; both- \$61.70.

### edTPA UPDATE

#### **edTPA Summary of Results**

There were a total of 355 edTPA submissions for the 2013-2014 academic year. Overall, our average score for the entire year across all programs is 44.2. This is above the national cut score recommendation, which is 37 – 42. Our lowest average rubric for all of our data was a 2.5 on Rubric 13: Student Use of Feedback. Our highest average rubric for all of our data was 3.4 on Rubric 1: Planning for Content Understandings. We should be very proud of our performance in the first full implementation year!

#### **Submission Reminder**

We are still waiting to receive scores for several students. Please remind your students that their portfolio is not officially submitted until they log in to the Pearson website and confirm their submission. They will receive a confirmation email from Pearson when the portfolio has been submitted for scoring. It is easy for students to miss this final step and we appreciate you reminding them next year. Kristall Day has been in contact with students who need to complete this final step, but please follow-up with your students as well.

#### **edTPA Terminology**

**Learning task:** Includes activities, discussions, or other modes of participation that engage students to develop, practice and apply skills and knowledge related to a specific learning goal. Learning tasks may be scaffolded to connect prior knowledge to new knowledge and often include formative assessment.
