FACULTY/STAFF SPOTLIGHT: DR. TIFFANY WILD



Dr. Tiffany Wild

Dr. Tiffany Wild is an assistant professor in the Department of Teaching and Learning with research expertise in visual impairments, science education, and engineering education. She oversees the Program in Visual Impairment along with program manager Danene Fast.

Dr. Wild indicates that the Data Summary Reports have enabled faculty to make changes to improve the program. Overall, the data suggests interns are prepared. They saw an opportunity for growth in learning and teaching of the literary braille code because the licensure testing now requires a transcribed braille sample. Two improvements that have been made in the program are:

1. Students must now pass a comprehensive braille transcription test

2. Additional coursework in teaching braille has been added. Assignments are now required to be submitted in braille

Dr. Wild hopes that additional practice will allow the interns to be successful in licensure examinations and, more importantly, teaching their students braille. She also hopes that the additional teaching methods will help interns improve lesson plan development on the edTPA.
