**FACULTY/STAFF SPOTLIGHT: DR. SHARI SAVAGE**



**DR. SHARI SAVAGE**

Dr. Shari Savage is an Assistant Professor in the Department of Arts Administration, Education and Policy and serves as Chair of Undergraduate Studies, which oversees the Bachelor in Art Education Program (BAE), a four-year degree with Pre-K-12 Multi-age licensure. Students typically begin in the BFA program and apply to the highly competitive BAE Program at the end of their sophomore year. Once admitted, students' progress through art education theory, art methods, curriculum development, field-based observations, and advanced studio courses before being placed in Columbus area art classrooms for their Student Teaching Practicum. Also unique to our program, we offer study abroad opportunities in Finland, Jamaica, and Ireland, which focus on global awareness and educational issues.

**Use of Data**

Data from recent edTPA pilots showed improvement was needed in differentiating curriculum for special needs students in the art classroom. We applied for a National Art Education Association (NAEA) Grant to help redesign our special needs course and are currently updating content and expanding field-based experiences. In addition, we purchased new textbooks and adaptive art making equipment for pre-service student use, which assists in understanding how to develop successful classroom art making experiences for all students.

## **DATA COLLECTION AND REPORTING**

There are increasing demands for data collection from pre-service programs from a variety of sources. For example, we are now required to answer the following questions about each of our 46 programs:

Who applies to your program? Who is accepted? If not accepted, why not? If accepted, do they enroll? If not, why not? If they enroll, how long did it take to complete the program? If they complete, did they apply for a license or endorsement? If they obtained a license/endorsement, did they get a job? Where? What are the Value-Added scores for his/her first five years? What are the RESA scores? What are the teacher evaluation scores?

We are responsible for a variety of data reports and appreciate all of your support and help in the process. We thought you might appreciate seeing some data requirements collected by our office.

## **STUDENT TEACHING OBSERVATIONS - UPDATE!**

We are no longer required to have a minimum of six (6) observations during student teaching. We are required to have some observations in TK20 that are aligned to the Ohio Standards for the Teaching Profession. Each program should decide how many are appropriate for your program, students and placements. *We recommend* a program consider 4 to 6 observations and that at least two (2) be face to face. **Language functions:** The content and language focus of the learning task represented by the active verbs within the learning outcomes.
