FACULTY/STAFF SPOTLIGHT: BRITT COLLIER-GIBSON



Britt Collier-Gibson is the coordinator of field experiences and placements in the School of Teaching and Learning at OSU Lima, and is currently a doctoral student in OSU's Educational Administration program. Eight years ago, she collaboratively established a field experience program based on a Professional Development School model of teacher preparation. Building partnerships between the teacher education program and school districts in northwest Ohio has been Britt's main focus for most of her 12 years at OSU Lima. She has also developed outreach programs and service learning-based courses, with the goal of bridging theory to practice and building mutually beneficial relationships between schools and the university to enhance OSU's land grant mission. Some of Britt's research

interests include mentor-mentee relations, co-teaching models of student teaching, teacher professional development, and female leadership in education.

Use of Data in Clinical Education

The edTPA assessments have provided data that corresponds strongly with data collected in field assessments and field observations. In addition, students, cooperating teachers, and principals are surveyed to determine programmatic needs. These data results are discussed at program meetings and have helped to shape curricular changes. The strong employment trends of OSU Lima graduates, especially in partner school districts, provides evidence of the benefit of university-school partnerships and the year-long internships that senior level teacher candidates experience alongside strong course curriculum and instruction.

NCATE LEGACY VISIT UPDATE

An agenda for the April 26-28 NCATE Legacy visit will be determined by the Board of Examiners by mid-March. Our initial Institutional Report (IR) submitted in September 2014 included 224 attachments and more than 8,500 pages.

In response to the IR, the BOE team had 44 follow up questions. To create our Pre-Visit Report Addendum due early March, applicable questions have been sent to department chairs or program leads. We appreciate the data and explanations received thus far and are looking forward to completing the Pre-Visit Report to be sent to the BOE and shared at the March 6 UTEC meeting.

PROPOSED INITIAL LICENSURE PROGRAM FEE UPDATE

Thank you to all faculty and staff that have helped collect more than 500 survey responses from students! The support from students, faculty, and staff has been overwhelmingly positive.

The UTEC Ad hoc Fee Committee is discussing a proposed program fee to build TK20, one OAE test, and the edTPA into fees and tuition and enable those costs to be covered by financial aid. The proposed fee, now called the "Educator Preparation Program Voucher", will apply to new autumn 2015 declared majors and limited to the cost of the vouchers (no overhead, no hidden costs). Details will be included as the proposal moves forward for consideration.

An open forum for Educator Preparation programs will be held on Wednesday, March 25th, from 3:30 - 5:00 pm. in PAES 145 and Friday, March 27th from 10:00 – 11:30 a.m. via Carmen Connect. The forum will discuss preparations for the upcoming NCATE legacy visit, P-12 placement updates, Unit-wide data and will include a discussion about edTPA. TK20 UPDATE

Access to Program Key Assessments inside TK20

Overseer access for TK20 should be in place for Spring of 2015. Most programs have a designated person to look at program key assessments data entry for courses and field placements. This is a first try for this system. If your program would like to designate someone please let us know.

edTPA UPDATES

edTPA Licensure Discussion

The Ohio Educator Standards Board did not discuss making the edTPA a licensure requirement at the January meeting. Presently the edTPA is included in our State Report Card. The plan is to include the edTPA in the fall agenda of the Ohio Educator Standards Board.

New Feature for edTPA registration and submission

The Office of Educator Preparation can now run reports that will tell us if candidates have registered for edTPA and successfully submitted edTPA to Pearson. If you would like an update on students in your program during the registration and/or submission process, please contact [Kristall Day](#).

edTPA Continues to Grow in Ohio and Nationally

During July 2014 – December 2014, a total of 5,848 candidates across the nation, including 1,026 candidates in the state of Ohio, submitted edTPA for national scoring. During the 2014-2015 academic year, a total of 35 Ohio Educator Preparation Programs will submit edTPA portfolios to Pearson for national scoring. Early Childhood and Special Education represented the largest groups in the state who submitted in the fall.

Tip #2: General Tips & Getting Started

Get Organized- - Buy a 2 inch binder. Print the Handbook and Making Good Choices document. Open the templates in Word, expand the blank spaces so you have room for notes. Print the templates. Put everything into the binder. Get some highlighters. Get a dedicated flash drive. Put your name on it!
