

# **OHIO ASSESSMENTS FOR EDUCATORS (OAE): Pass rates for 2014-2015 tests**

As we are wrapping up the year, it may be useful to see data results and reflect on how the data may be used for program improvement. Results from the OAE tests are summarized below. Detailed results are available to faculty leads in the Buckeye Box.



Areas with less than 10 test takers, but 100% pass rates, include Agriscience, Chemistry, Computer/Tech Subtest I, Family and Consumer Science, Health, Integrated Social Studies, and Physics.

## First Release of 2015 edTPA Handbooks Now Available

The Stanford Center for Assessment, Learning, and Equity (SCALE) has updated the edTPA handbooks for 2015–16. Updates are focused on making edTPA expectations clearer and include directions, prompts, required artifacts, and rubric language.

Handbooks will be released in three groups: mid-May, early June, and mid-July. A list of changes to each handbook will be posted in the Resource Library by June 1. Detailed information regarding the release of operational 2015 templates for candidate use will be provided in early June.
