#### RESIDENT EDUCATOR LICENSE RENEWAL UPDATE

The Resident Educator license is able to be renewed indefinitely, until one begins teaching. This will accommodate students that enter the military, move to another state, or do not go directly into teaching. It should be noted that if laws or program requirements change, then getting recommended may take additional coursework. Therefore, it is in a student's best interest to apply for a license or endorsement upon completion of a program.

## DEBUNKING THE MYTHS OF WORKING IN CCS

The EHE's Office of Career Services recently held an on-campus panel discussion with several Columbus City School (CCS) employees and EHE students. The panel consisted of two principals, a recent OSU education licensure graduate working in CCS, a veteran teacher, a Human Resource specialist, and members of CCS's Professional Learning and Licensure office. Over 70 students attended, asking questions about services CCS provides, areas of concentration in which CCS is likely to hire, diversity of teachers, opportunities for team teaching, and questions about grade levels and licensure. ## **OAE UPDATE**

## Early Childhood Education Special Education OAE and AYA Language Arts OAE

As reported in the September *Ed Prep Express*, the Ohio Educator Standards Board had recommended reducing the standard error of measurement (raw score required for

passing) for the Intervention Specialist: Early Childhood OAE test and the AYA Language Arts OAE test. Upon a second review by the State Board of Education, they approved this recommendation. Bottom line: The raw cut score is lower, but the score candidates see will remain at 220). The change is not retroactive, but will be in effect this fall.
