

CAEP CORNER

Getting to Know the CAEP Standards: Standard 1.3

CAEP Standard 1 focuses on candidates' "Content and Pedagogical Knowledge." Standard 1.3 requires that "Providers ensure that candidates apply content and pedagogical knowledge as reflected in outcome assessments in response to standards of Specialized Professional Associations (SPAs), the National Board for Professional Teaching Standards (NBPTS), states, or other accrediting bodies (e.g., National Association of Schools of Music – NASM).

This fall, **15** programs (~20 licensure tracks) in OSU's EPP will be submitting SPA reports in **September 2016** to meet this standard. Your efforts to assist with this process are much appreciated!



OAE UPDATES

Prohibited Materials Update

The Prohibited Materials list of the Ohio Assessments for Educators (OAE) website has been updated. Due to recording devices that fit into eyeglasses, testing sites may ask an examinee to remove his/her eyeglasses for a visual inspection. The test center proctor will not touch or handle the eyeglasses. A comprehensive list of prohibited materials may be found here.

New Reading Test

Starting July 1, 2017, Early Childhood Education, Middle Childhood Education, and Early Childhood Intervention Specialist candidates will be required to take an OAE for Reading. These candidates will also meet the state requirements for the 3rd Grade Reading Guarantee.

Alternative Testing Arrangements

Those students that may be requesting Alternative Testing Arrangements such as ELL's with extra time or disability accommodations will need to follow this procedure (directions are available at

http://www.oh.nesinc.com/FindInfo.aspx?c=Alternative%20Testing%20Arrangements.)

- Go to the OAE site http://www.oh.nesinc.com/
- Select the test
- Pay for the test

DO NOT sign up for a specific date or location. DO send needed documentation to Pearson. See also:

- Alternative Testing Arrangements Request Form
- AND either Required Documentation
- OR Institutional Verification of Documentation

WAIT for Pearson Accommodations Officer approval of accommodations, then schedule the day/time of test.

OAE Results

Most OAE test results are posted within four to six weeks. Some specialty tests are posted in eight week intervals. These tests include: Educational Leadership and Reading (Subtests I & II). Please help your students plan accordingly.

OAE Practice Tests

Practice OAE tests are available online. There are free practice questions. Also, one can purchase a full practice test online. (<u>www.oh.nesinc.com</u>)

NOTICE: The OAE tests may be retaken every 60 days. Therefore, please have your students plan time for results and possibly a re-take if necessary.

HOW TO APPLY FOR LICENSURE

If students ask, here are some answers:

How do I apply for my license?

• Apply on-line at <u>https://safe.ode.state.oh.us/portal</u>.

What is the cost to apply for my license?

• The cost to apply for your license is \$160

I need a current background check, how do I know if it is current?

 It is the candidate's responsibility to ensure their background checks will be current when applying for a license. If the candidate needs to complete a background check please visit: <u>http://ehe.osu.edu/educator-</u> preparation/background-checks/.

BACKGROUND CHECKS

Please remind students entering a placement for fall term 2016 they MUST have a background check on file with the campus where they are doing their placement. If they do not, they may not enter their placement.

Important reminders for students:

Another Task Tip: Not Feed Back... Feed Forward

Feedback needs to point P-12 students to a goal. It should register discrepancy between the current state and a known objective. It's not really just feedback, it's feed FORWARD --- help the students know what they have to do to get better, to learn more.
