Tk20 TRAINING DATES FOR THE NEW GRAPHITE TK20 USER INTERFACE

Mark your calendars now for training on the new Graphite Tk20 User Interface. Two dates are available:

August 16, from 10 a.m. to Noon in Ramseyer 329

September 7, from 2 to 4 p.m. in Ramseyer 329

The first hour will cover basic functionality for faculty and supervisors, as well as a brief overview from the students' perspective so faculty can see what a student sees.

The second hour will delve in to deeper Tk20 functionalities, such as reports, transitions points, etc.

The University Teacher Education Council (UTEC) has been discussing significant developments as part of on-going conversations regarding admission standards for teacher preparation programs at Ohio State. VOUCHER PROGRAM UPDATE

The Ed Prep Voucher Fee is being fully implemented for Fall 2016 undergraduate and M.Ed. initial licensure admits. Please do not ask students to purchase Tk20 if they are in these programs.

Thank-you to the UTEC Voucher Committee (chair, Greg Rose), with special help from Andy Zircher and Kelly Crawford, processes and timelines are being developed. For new admits, a Tk20 account will be created in the first weeks of each term. For candidates that are in their second semester of the fee, an OAE voucher will be provided to candidates. For student teachers, the edTPA voucher will be given during the first week of the student teaching term.

Beginning in spring 2016, Ed Prep Voucher recipients will be drawn from a subplan in SIS. When students change their major, the advisor will assign the subplan code: 1LC. That list will be compared to the to the Tk20 application for each program.

STUDENT PLACEMENT REQUIREMENTS REPORT NOW AVAILABLE

A report is now available for program managers to see the status of their students' documents and module completion. To access the Student Placement Requirements Report:

- Log into Tk20
- Click on "Reports"
- Search for "Student Placement Requirements"
- Enter class information, hit "submit", and the report will be generated.

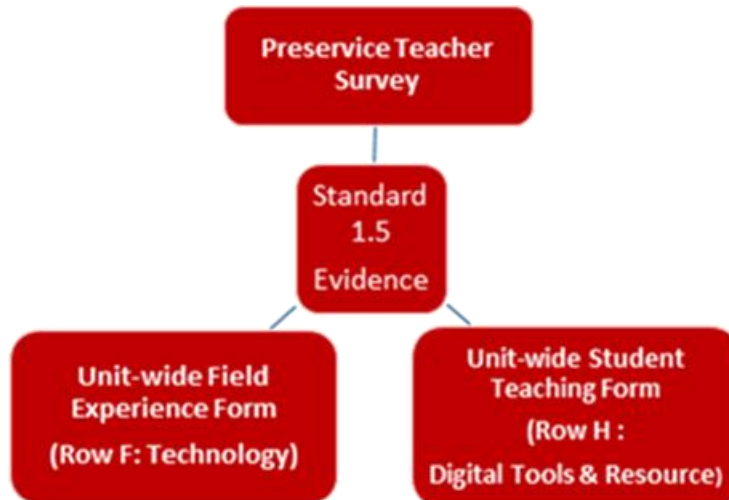
If students have not enrolled in class by the latest Tk20 upload, they will not be included in the report.

CAEP CORNER: GETTING TO KNOW THE CAEP STANDARDS: STANDARD 1.5

CAEP Standard 1 focuses on candidates' "Content and Pedagogical Knowledge." Standard 1.5 requires that "*Providers ensure that candidates model and apply technology standards as they design, implement and assess learning experiences to engage students and improve learning; and enrich professional practice.*"

CAEP requires EPPs to provide multiple measures of evidence from valid and reliable instruments. *At present, OSU plans to provide evidence for this standard from:*

NEW READING TEST FOR EARLY, MIDDLE, AND EARLY CHILDHOOD INTERVENTION SPECIALISTS

Beginning in Fall of 2017, all early childhood, middle childhood, and early childhood intervention specialists (early childhood special education) licensure students will be required to take an Ohio Assessment for Educator (OAE) reading test. Even though it is not required until 2017, districts have informed us they will give hiring preference to students that have passed this particular test. Competencies for this test may be found [here](#). The test will be available in fall of 2016 and is based on a test from Massachusetts.
