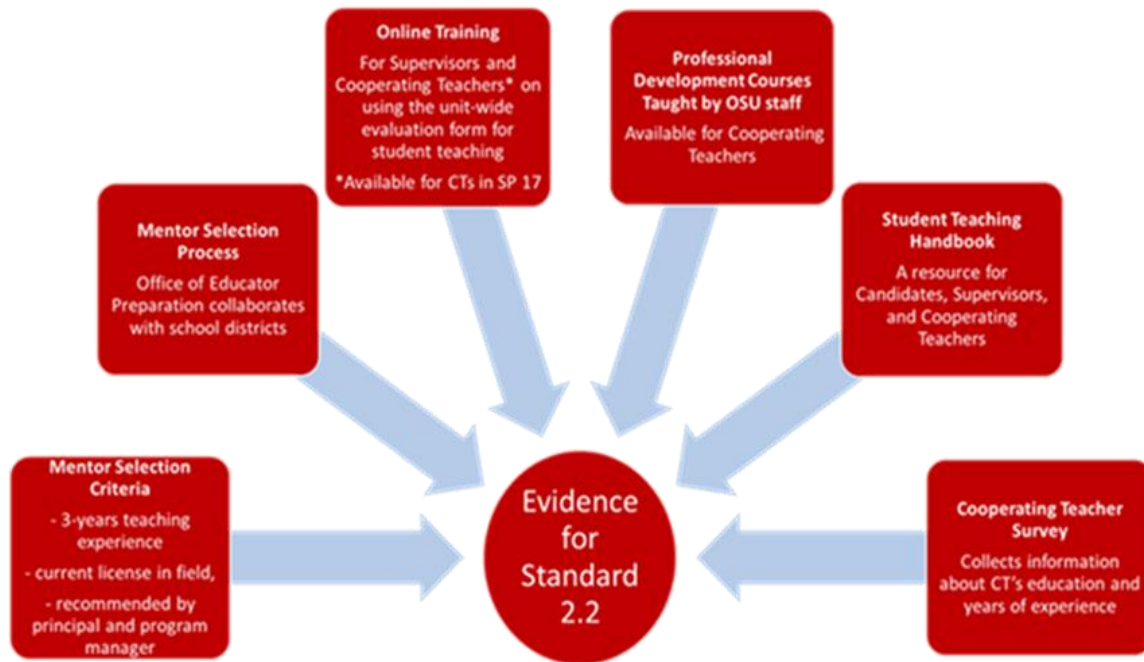

**Getting to know the CAEP Standards: Standard 2.2**

CAEP Standard 2 focuses on "Clinical Partnerships and Practice." Standard 2.2 requires that *"Partners co-select, prepare, evaluate, support and retain high quality clinical educators, both EPP and school-based, who demonstrate a positive impact on candidates' development and P-12 student learning and development. In collaboration with their artners, providers use*

multiple indicators and appropriate technology-based applications to establish, maintain and refine criteria for *selection, professional development, performance evaluation, continuous improvement, and retention of clinical educators* in all clinical placement settings.”

CAEP requires EPPs to provide multiple measures of evidence from valid and reliable instruments. Below is a sample of the evidence OSU plans to provide evidence for this standard:

## FALL 2016 OHIO DEPARTMENT OF HIGHER EDUCATION (ODHE) PROGRAM REVIEW SUBMISSION

On October 10, 2016, OEP staff submitted 25 Ohio Department of Higher Education state reports on several programs' behalf. Information was gathered about the programs' origin and status, faculty, curriculum, field and clinical experiences, and key assessments. Several documents were included in each submission: curriculum vitae/resumes; syllabi for required courses; standards crosswalks; program sheets; assessment descriptions and performance data. We greatly appreciate the support from those who provided relevant information for these reports.

## OHIO ASSESSMENTS FOR EDUCATORS (OAE) TEST RESULTS

The State Board of Education approved updates to the OAE Middle Grades content assessments. The assessments were modified to limit the grades' 9-12 content to 1/6 of the test (since there are no 9th grade standards, but the license is through 9th grade). The scaled passing score is 220.

Updates to the following assessments have been approved by the State Board of Education of Ohio:

- Middle Grades English Language Arts (028)
- Middle Grades Mathematics (030)
- Middle Grades Science (029)
- Middle Grades Social Studies (031)

## **SEVEN DISTRICTS REQUIRE STUDENTS TO HAND DELIVER BACKGROUND CHECKS**

Program Managers and Faculty Leads on the Columbus Campus, please remember that seven school districts require students to *hand deliver* background check documents to their district office. The districts are: Canal Winchester, Dublin, Groveport-Madison, Hamilton Local, Olentangy, Westerville, and Worthington. Please tell your students to make sure their documents are on file with both the Office of Educator Preparation (OEP) **and** the district office where they are placed.

As a reminder, OEP *no longer* has copies of students' background checks. Students must go to the Office of Human Resources at the Gateway (1590 N. High Street, Suite 300, Columbus, OH) to obtain copies of their background checks.

## **SUPPORT FOR CANDIDATES TAKING LICENSURE TESTS**

Many candidates have strong potential as educators, but struggle to pass the licensure tests. For some students, it is helpful to offer practice tests and feedback to help combat their test anxiety. One of AACTE's affiliate members, Teachers Test Prep, offers free on-line diagnostics and other services to help candidates improve their exam performance. They receive an instant diagnostic breakdown indicating their strengths and weaknesses, and their overall likelihood of passing. Identifying at-risk students early on is the key to providing the support these students need for success.

If a program chooses to use this service, a designated administrator will also receive compiled reports to help identify at-risk students.

## **TEACHER SHORTAGE AREAS**

The annual Teacher Shortage Nationwide List was recently published (August 2016) by the U.S. Department of Education. For individuals that complete programs that are listed as shortage areas for Ohio, they may be eligible for Federal Perkins Loan cancellation of up to 100 percent of loan repayment or qualify them for loan deferment.
