50 HOUR FIELD REQUIREMENTS IN NEW OAC

The new [Ohio Administrative Code](#) of requiring 50 clock hours of field experience for all endorsements and second licenses will have a phase-in period, despite the fact that they went into effect this month. Therefore, the new field rules should be reflected for students being admitted to programs beginning fall 2017. Programs submitted for state approval during fall 2017 should also reflect these new rules.

HELPFUL REPORT AVAILABLE ON STUDENT PLACEMENT REQUIREMENTS

How can you efficiently find out if your students have met the requirements prior to their field placements, especially student teaching? The answers are at your fingertips! Run the Student Placement Requirements Report in Tk20. Crucial information such as Module I completion, background check expiration dates and OAE scores are listed in one place. Step-by-step directions to run the report are posted in the Ed Prep Buckeye Box.

DISTRICT MEETING A SUCCESS!

APPEALS GUIDEBOOK

Approval for the Appeals Guidebook was approved by UTEC. The guidebook includes processes for program appeals and student-initiated appeals. A copy of the guidebook is in each program's Buckeye Box or the unit box.

UPDATED OAE SCORES FOR STUDENT TEACHERS

Updated OAE scores for spring 2017 student teachers have been updated to the Ed Prep Buckeye Box for each program. Look in your Data for (Program) → OAE Data folder. Information to submit appeals can be found in the Appeals Guidebook (see section above).

WHEN ARE STUDENTS CHARGED \$25.00 FOR ODE LICENSURE APPLICATIONS?

If a student applies for a license through the Ohio Department of Education (ODE) SAFE account and the license is not approved, there are four possibilities. For three of the four, the student is charged a \$25 processing fee (the student withdraws the application, the application passes the 180 day limit, or ODE declines the application). However, if OSU declines the application, the students are not charged the \$25 fee. Please contact [Casey Hammond](#) if you have questions.

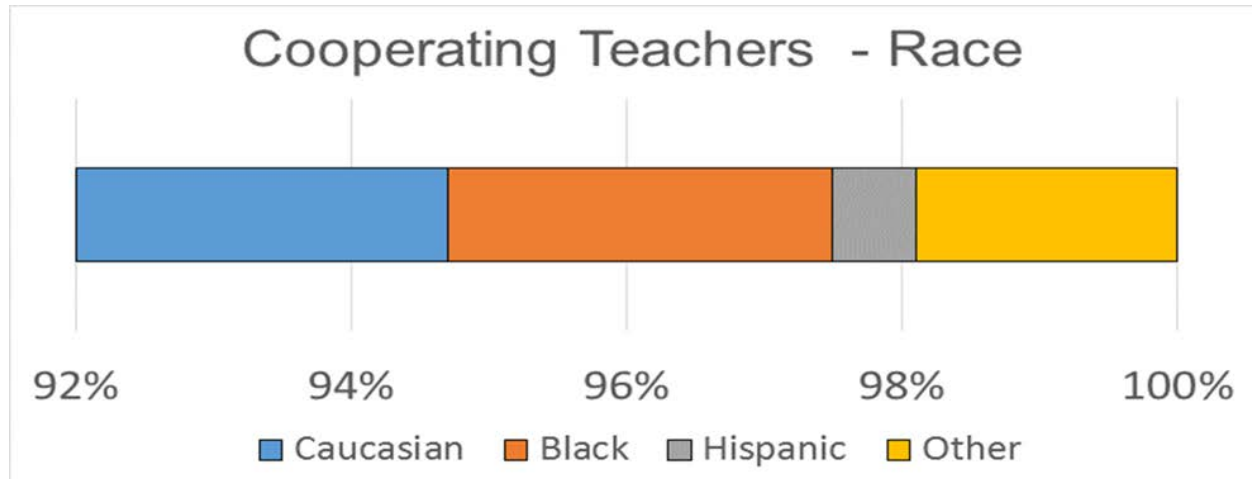
CREDENTIALING OF 12TH GRADE TEACHERS FOR DUAL ENROLLMENT STUDENTS

Teachers who teach dual enrollment courses are required to have either a masters in the content area or a coherent 18 hours of content area graduate level coursework. Ohio State and the Education Services Center of Central Ohio recently met to discuss how Ohio State might become involved. A pilot effort is anticipated to begin in summer 2018.

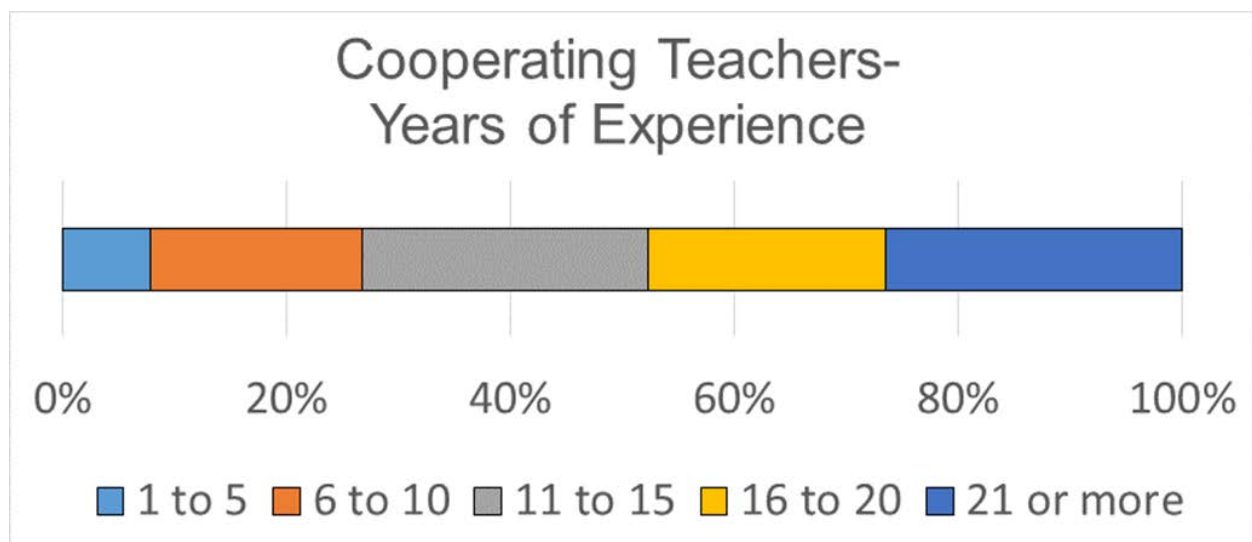
WHO ARE OUR MENTORS/COOPERATING TEACHERS?

The graphs below give a quick glimpse of race and years of experience of the group. The data are respondents to our spring 2016 and fall 2016 cooperating teacher survey.

As you look at this data, consider asking yourself, what does it tell us about our own cooperating teachers? How might we recruit more diverse cooperating teachers?



CTs surveyed were 94.7% Caucasian, 2.8% Black, 0.6% Hispanic, and 1.9% Other.



FREQUENTLY ASKED QUESTIONS ABOUT THE VOUCHER PROGRAM

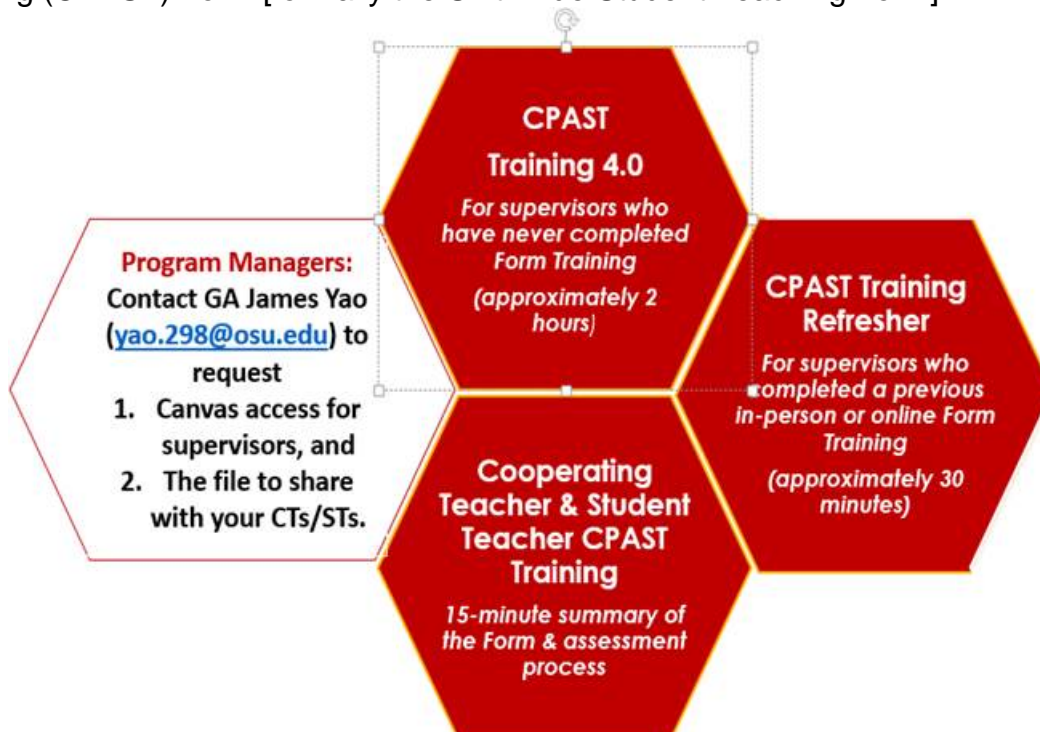
Who is part of the voucher program?

Undergraduate students enrolled autumn 2015 or later and graduate students enrolled Autumn 2016 or later may be part of the voucher program. Currently, post baccalaureate students are not part of the voucher system.
