CHANCELLOR PROPOSES CURRICULUM ADDITION FOR OPIOID AND ADDICTION EDUCATION

Chancellor John Carey issued a directive that "all state-assisted institutions of higher education update the teacher preparation curriculum for all content areas and grade levels so that teachers graduating...have all the necessary information to educate students about the consequences of opiate and other substance abuse as well as the resources available to help fight the opiate epidemic."

Carey has the ability under state law to make curricular directives for educator preparation programs. Requirements are to:

1. Update their teacher preparation curriculum.
2. Ensure that the update applies to all content areas and all grade levels.
3. Provide information about resources available to help fight opiate and other substance abuse.
4. **Begin offering the new curriculum this fall.**

UTEC is not considering a cut score for edTPA. Any edTPA minimum score requirements should be established by program and apply to all candidates within that program.

For the approximately 250 edTPA scores received from Spring 2017 to date, the average overall score is 46.1 points with a new high score of 70
