edTPA UPDATES

edTPA Resources Updated for 2017-18

Pearson released updated versions of several edTPA resources for the upcoming academic year: Making Good Choices, Understanding Rubric Level Progressions (by subject), Academic Language Summary Handouts (by subject) and handbooks for Special Education, Classical Languages and World Languages. 2017-18 edTPA Score Report Dates

Pearson also recently released the 2017-18 edTPA Score Report Schedule. It has been added to your Ed Prep Program's Buckeye Box in the edTPA Resources folder.

Last year, some portfolios were challenged for plagiarism. To make it possible to address possible problems, we recommend programs require submission so scores may be obtained before the end of the semester. Therefore, we recommend edTPA portfolios be submitted by:

-November 9 for Autumn 2017 student teachers

-March 29 for Spring 2018 student teachers

CPAST AND PRE-CPAST FORMS UPDATED FOR 2017-18

As of May 31, minor adjustments to the language in the Cpast (Unit Wide Student Teaching) form and Pre-CPAST (Advanced Field Experience) form were made for the 2017-18 academic year. The language referencing standards has been changed to say P-12 state learning standards. If you've already made copies of the Cpast form, you may continue to use the previous version.

Note: The scale for the scoring of the Pre-CPAST form has also been adjusted to a 2-1-0 scale to better align to the Cpast performance levels. You may find the updated version in the "Key and Unit Rubrics, Assessments & Instruments" folder in your program's Ed Prep Buckeye Box.

UPDATED OAE SCORES

Updated scores for OAE tests taken prior to June 5 have been posted to your program's Ed Prep Buckeye Box in the Data > OAE Data folder. The overall pass rate for this set of scores (n=229) is 82% with an overall average score of 242. The next batch of scores will be updated by July 21.

ADDITIONAL SP17 COOPERATING TEACHER/MENTOR SURVEY FEEDBACK POSTED

The qualitative feedback gathered from the Spring 2017 Cooperating Teacher/ Mentor Survey has been disaggregated by program and posted in your program's Data> Other Data folder on Buckeye Box. It includes comments submitted about the strengths of your CT training, additional requests for support and overall suggestions for improvement. Only programs with more than three respondents have been shared to protect anonymity.

FREQUENTLY ASKED QUESTIONS ABOUT THE VOUCHER PROGRAM

OEP has received several inquiries about OAE vouchers from M.Ed. students. As a reminder, only undergraduate students receive an OAE voucher, while all initial licensure students receive Tk20 and edTPA.

New Tk20 student accounts will be activated the week of June 26 for students who paid their first Ed Prep Voucher fee in Summer 2017.
