UPDATED OAE SCORES

Autumn 2017 Student Teacher OAE Scores

Updated files with OAE scores for Autumn 2017 student teachers have been added to your program's Buckeye Box in the Data for Program> OAE Data folder. As a reminder, students must pass all of their OAE tests required for licensure in their area prior to student teaching, including the new 090 Foundations of Reading Test for Early Childhood, Middle Childhood and Special Education students.

Remember, programs may file an appeal on behalf of students who have yet to pass one test. Please complete the appeal before they begin student teaching.

However, if more than one test to take or pass is needed, students must file their own appeal paperwork with the UTEC Appeals Committee. See additional details in the Appeals Guidebook, located in your Buckeye Box. Please submit student appeals in sufficient time for the UTEC Appeals Committee to virtually meet and vote on August 19. If you support the student appeal, please note that as well.

ODHE UPDATES

Pre-Service Survey Results

Results from the 2015-16 Pre-Service Survey are in! The Pre-Service Survey is distributed to candidates during student teaching. The OSU average scores increased from 2014-15 to 2015-16 the greatest in the following areas:

- Q1: Prepared me with knowledge **of research** on how students learn.
- Q20: Prepared me to **treat all students fairly** and establish an environment that is respectful, supportive and caring.
- Q23: Collected evidence of my performance on **multiple measures** to monitor my progress.
- Q31: Provided field experiences that **supported my development** as an effective educator focused on student learning.

In contrast, OSU average scores decreased the greatest in the following areas:

- Q2: Prepared me to recognize characteristics of **gifted students**, students with **disabilities** and **at-risk students** in order to plan and deliver appropriate instruction.
- Q21: Prepared me to **use technology** to enhance teaching and student learning.
- Q30: Provided knowledge about the **Value-Added** growth measure.
- Q37: Provided opportunities to understand students' **diverse cultures, languages** and **experiences**.

Results are disaggregated by program and level, so please take a few minutes to review them in your Buckeye Box.

Program-specific data are included on the annual Performance Report and shared publicly for programs with sample sizes of ten or greater. Results from 2016-17 will be shared once we receive them next spring.
