CAEP UPDATES

CAEP 2.1 – Technology-Based Collaborations with P-12 Partners

Are you wondering how to collaboratively use technology with your P-12 partners? Below is one example to get your creative juices flowing!

Agriculture Education utilizes Google Hangouts to share lessons with P-12 classroom partners. How does it work?

- An elementary teacher and Ag Ed student select a topic (e.g., Apple Orchards), The Ag Ed student
- recruits an expert who connects while in their own orchard
- Writes the lesson plan and sets up Google Hangout as the venue
- Facilitates the discussion and lesson between the P-12 children and the expert

This is just one example of how programs and P-12 partners collaboratively use technology!

The 2017-2018 CAEP Support Timeline for Programs was recently updated. It is located in the Unit Information and Key Assessments folder in Buckeye Box.

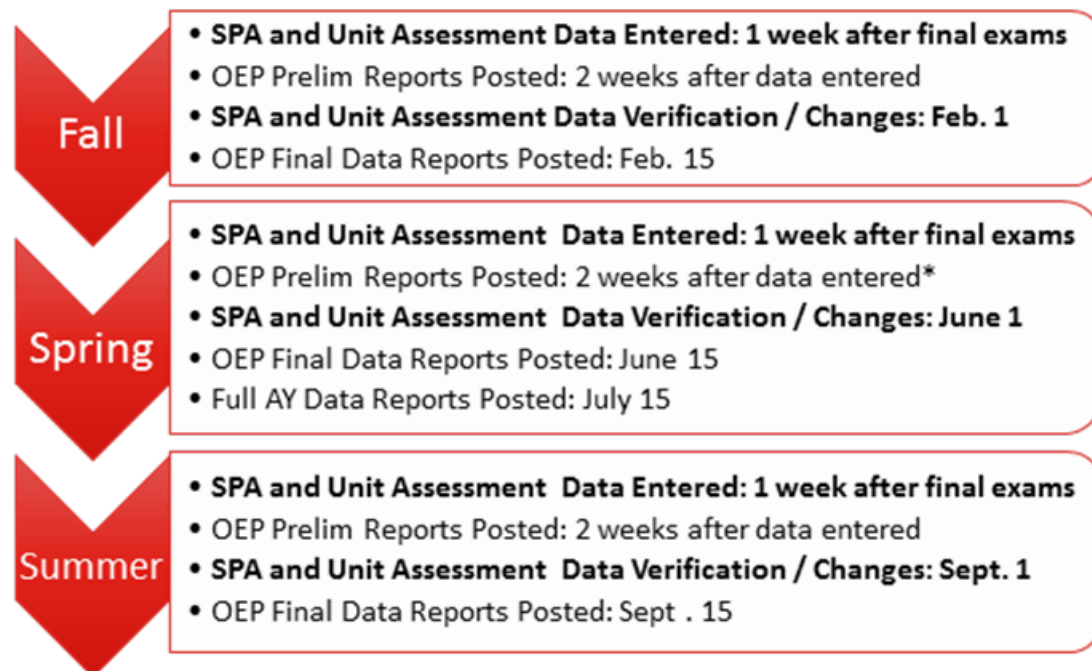

Tk20 Data Submission and Reporting Timeline

Below is an updated Unit and SPA assessment data submission timeline to help ensure the timeliness of data collection, analysis and reporting at consistent intervals. The timeline is important, as OEP will need to report all 2017-18 academic data for the CAEP report. (Note: Bolded items are to be completed by programs.) Please review and contact [Jacob Chacko](#) if you foresee any challenges.



For T&L Columbus programs, the following schedule will be staggered for Spring semester:

- **English, Social Studies and MCE:**
 - Program data entered: 1 week after final exams
 - OEP Prelim Reports Posted: 1 week after data entered
 - Program Data Verification / Changes: 1 week after Prelim Reports posted
 - OEP Final Data Reports Posted: 1 week after verification
 - **TESOL, FSLED, STEM Math and Science, ECE:**
 - Program data entered: 1 week after final exams
 - OEP Prelim Reports Posted: 2 weeks after data entered
 - Program Data Verification / Changes: 1 week after Prelim Reports posted
 - OEP Final Data Reports Posted: 1 week after verification

UPDATES ABOUT VOUCHER PROGRAM

ARE YOUR STUDENTS ELIGIBLE FOR TEACH GRANTS?

The Federal Teacher Education Assistance for College and Higher Education (TEACH) grant is awarded to students that earn licenses in high need fields and will teach in low income schools. Students may be eligible for Federal loan forgiveness or deferment. For 2017-18 in Ohio, high need fields are: Arts; English/Language Arts; Foreign Languages*; AYA Mathematic*, AYA Science*; AYA Social Studies; School Psychologist, Special Education; Speech/Language Pathology; and TESOL.

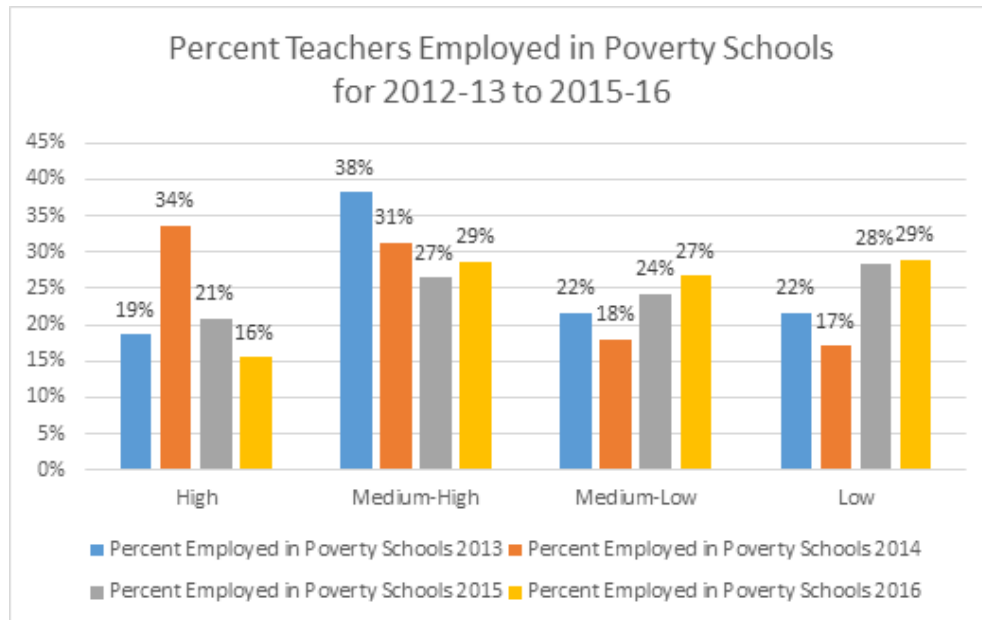

ODHE UPDATES

OSU Alumni Employed in Poverty Schools Decreasing

ODHE recently provided data on Ohio State alumni who graduated recently and are teaching in Ohio public schools. It allows us to see the percent of teachers employed in poverty schools (below). The data is provided in an anonymous form, and therefore cannot be further broken down by programs and campuses.

The percentage of OSU recent grads teaching in high and medium high poverty schools has decreased since 2013.
