Student Teaching Survey Results

In SP22, APL distributed the Cooperating Teacher/Mentor Survey (78% response rate) as well as the Opportunities in Student Teaching Survey (50% response rate). Highlights of these results include:

- At a rate of 96%, CTs would accept another OSU candidate, and 92% were satisfied with the quality of OSU's supervision.
- At a rate of 93%, student teachers indicated they participated in coplanning lessons, and 92% were challenged to implement new, researchbased institutional strategies.

Foundations of Reading OAE Changes

The Foundations of Reading (090) assessment has been updated. Pending State Board of Education of Ohio approval, Foundations of Reading (090) is anticipated to retire in AU22, and it will be replaced by the updated Foundations of Reading (190) assessment starting AU22. We will share additional information about Foundations of Reading (190) as it becomes available. Students should continue to take the 090 OAE, until the new exam is available. Passing scores on the 090 received prior to the availability of the 190 will be honored for the RESA license.
