#### 2021-2022 Placement Statistics

Current reports detail that in 2021-22 across all campuses,1,027 licensure students had 1,977 field placements in 462 different locations in 133 different districts/agencies. This brings the total number of hours in field experiences, student teaching, or internships to 375,924 for the 21-22 academic year! Additionally, from July 1, 2021 – June 31, 2022, 618 students were awarded their educator license or endorsement.

Please note that 2021-2022 numbers are still being reported. APL will communicate the final numbers when they are submitted.
