Field Placement Supervisors

Supervisor confirmation files are now available in BuckeyeBox for updates. APL <u>must</u> have all supervisor assignments for **Spring** semester by **December 15.**

Required CPAST Training

Supervisors:

As a reminder, all spring student teaching supervisors are required to complete an online CPAST training annually in Carmen before they conduct

their midterm 3-way conferences, no later than **February 1**. If you reported your supervisors to APL, they have been added to the proper course: the Initial training (approx. 90 minutes) for new supervisors and the Refresher training (approx. 30 minutes) for returning supervisors. A passing score of 80% is required. Please email <u>edprep@osu.edu</u> if supervisors are not seeing the appropriate course.

Cooperating Teachers:

It is the responsibility of the programs to train cooperating teachers on the use of the CPAST. There is a PowerPoint in <u>Box</u> that you are welcome to use if you feel that it would be beneficial for your CTs. As a reminder, Spring 2020 admission decisions for licensure programs in Tk20 were due by **December 1**. Please make sure the appropriate Final Result is reflected for each application in the queue (i.e. no blank or In Progress statuses). For newly admitted students, please work with advisors to ensure their SIS coding is also updated as soon as possible to ensure the Ed Prep Voucher fee is applied to their bills in a timely fashion.
