SP20 OSU Cooperating Teacher and Opportunities in Student Teaching Surveys

As a reminder, survey response rates and non-responder lists will be sent to programs at the end of the month. Please contact the individuals on the non-responder list to follow-up on completing the survey. As you may know, these surveys are brief (approximately 5-10 minutes to complete) and provide valuable feedback on OSU field experiences. This feedback is used to inform program and process improvement. Our goal is an 80% response rate and the surveys close on May 1.

Field Experience Placement Logs

As a reminder, programs are required to maintain student placement logs as an official record of placement attendance. These logs should contain the student name, course, building, date, time in/time out, and signature of the cooperating teacher for the full field experience. Programs are required to retain these logs for at least two years. File storage may be determined by each program (ex: Carmen Shell, BuckeyeBox, etc.)

Please note: Spring confirmations should reflect actual dates and hours logged, especially given the recent guidance regarding classroom teaching.
