New Placement Request Process

The Office of Accreditation, Placement, and Licensure serves as the liaison between the school district or agency in helping each program secure approval for the field placement. Always download the most recent field experience template and submit the desired field placements via the website at https://ehe.osu.edu/accreditation-placement-licensure/field-placement/.

When entering student assessment scores into TK20:

 N/A should <u>never</u> be entered for any line in the Pre-CPAST or CPAST.

- The minimum number of observation notes to be uploaded to TK20 for Advanced Field experiences is one.
- The minimum number of observation notes for Student Teaching to be uploaded to TK20 is three.
