#### **Placement Updates:**

- Fall placement requests will be sent in early April.
- As a reminder, some of our cohorts will be submitting year long requests.
- An overview of the year-long placement model in the Department of Teaching and Learning

- With this co-teaching/co-planning model, it keeps the student teacher and mentor involved year long.
- Importance of relationship building
- This will look different for each of you; talk with mentors, discuss syllabi, engage in conversations about assignments and what the year will look like.
- <u>Placement description catalog</u> will be included in the placement process. We're open to feedback from districts about what those placement descriptions look like.
- As a reminder, we need to place students with mentors who have the same license that the student is pursuing.
- <u>Science of Reading requirement:</u>
  - What we've learned is that higher ed institutions have a different timeline than K-12.
  - What we are hoping is that if you all are already tracking this information and have mentors who are trained, then we're hoping our students can be placed with those mentors.
  - We understand that the timelines are different so we're looking forward to more guidance from ODEW.

  - We're curious to hear from our district partners about this:
    - One district utilized LTRS training. There are concerns regarding whether even more training will be required, as LTRS included 75 hours.
    - Another district mentioned they have a tiered approach...K-1 teachers were trained this year, 2-3 have 6 hours now and will receive 12 hours next year...
- <u>Pre-service teacher permit: effective July 1</u>
  - Students will be required to apply for this, and we will have an e signature process.
  - Beginning in the Fall, our students will have gone through this process. You can assume that anyone in your building has this permit.
  - Students will be given an ID and will be valid for 1 year, but we've heard varying ideas on making it valid for 3 years.

- The pre-service permit *might* serve as a sub license as well, but we're waiting on confirmation. Districts frequently utilize pre-service teachers as subs.
- <u>Placement Coordinator onboarding:</u>
  - We have discussed developing a resource for folks to learn more about our processes and exchange information about everything there is to know about coordinating placements with Ohio State.
  - We are interested in feedback on what you would like to see in this onboarding.
- Growing and Retaining Mentors Committee:
  - There are several members on this call who have volunteered for this committee, and we thank you all.
  - Our hope is that this group can tackle a lot of the issues regarding the placement process. We are looking for ways to improve the experience and best support mentors.
