## LICENSURE UPDATES

#### Applying for Licensure – Updated version

#### **OCTEO Conference**

The spring 2019 OCTEO conference was held April 10-12, in Dublin, Ohio. Updates include:

Ohio Department of Higher Education:

#### P-5 Licensure Conversion

Spring 2020 ODE Office of Educator Licensure will offer P-5 and P-5IS as an option for e-signing.

Fall 2020 First Semester First-Year students begin under P-5 program requirements, no new students enrolled into early childhood licensure programs.

Programs may start as early as Fall 2019, but no later than Fall 2020.

June 30, 2024 Last issuance date for p-3 licenses. Only candidates on teach-out lists submitted that spring will be granted a license after this date.

Currently approved EC and ECIS licensure programs do not need to go through state review upon conversion. Beginning in Fall 2020, program review submissions for EC and ECIS should be submitted as the P-5 program.

Adapted Physical Education Endorsement: New national standards updated, committee reviewing

Computer/Technology Endorsement: Updated ISTE standards (new link provided) Computer Science Endorsement (new): Committee working now, end goal is August Media Arts Endorsement (new): anticipated pending Board Approval Theater/Drama Endorsement (new): anticipated pending Board Approval

Ohio Department of Education:

#### **Grade Band Changes**

PK-5 and PK-5 Intervention Specialist: Available for out of state applicants beginning July 1, 2019; available for Ohio institutions to e-sign beginning spring 2020. Phase out issuing PK-3 and PK-3 ECIS licenses on June 30, 2024.

#### New P-5 Primary OAE Tests

The P-5 Primary Assessment of Professional Knowledge (APK) and P-5 Primary Assessment of Content Knowledge (ACK) should be ready for students to take beginning in approximately March 2020.

Since the new OAE tests will be available before our P-5 Early Childhood cohorts will get licensed in Spring 2021, they are required to take these exams. The current P-3 APK and ACK tests will not be accepted. Please plan your testing requirements for students around this timeline.

**PK-12 Computer Science License:** New OAE test coming for Computer Science.

**Intervention Specialists:** Properly licensed for teaching most subjects to students with disabilities in grade range of license

HQT additional content requirements no longer apply. Mild/Moderate and Moderate/Intensive valid for teaching students with

any disability. Exception: courses specifically for students with visual impairments or hearing impairments.

**Licensure Code of Professional Conduct:** Licensure Code is being reviewed and updated. Proposed updates include:

ninth principle surrounding the use of technology; defines grooming and academic dishonesty; clarifies accurate reporting

requirements; and adding nepotism and sexual harassment.

## **ODE TIPS**

# The Top 10 Professional Conduct Concerns

Most educators care about their professional conduct, but they still can make small, avoidable mistakes that lead to larger

consequences. Here are 10 important concerns, in no certain order, that can get educators into sticky situations with

Ohio's Office of Professional Conduct.

1. **Falsification or Failure to Disclose**: Educators must accurately report their criminal and disciplinary histories, employment status and academic credentials every time they fill out employment applications or complete state licensure applications.

2. Emotional, Romantic and Sexual Relationships: Responsible educators never engage in sexual relationships with students or fail to keep proper professional and emotional boundaries in their relationships with students. Educators should be empathetic but know when to refer students to parents, counselors or mental health professionals.

3. **Social Media**: Responsible educators stay professional on all personal social media 24/7/365. They keep their personal profiles private, knowing unwise entries can result in discipline.

4. **Theft and Fraud**: Theft and fraud crimes, even if unrelated to the school community, are cause for discipline. Responsible educators know these crimes reflect poorly on the profession.

5. **Alcohol**: Responsible educators don't come to school smelling of alcohol, have alcohol in their systems or consume alcohol once there. They are responsible for the care, custody and control of students.

6. **Broken Contract**: Contracts are a two-way street. Public and community school educators should talk to their district or school administrators before resigning from positions.

Responsible educators know they may be disciplined for resigning during the school year or after July 10.

7. **Personal Gain:** Responsible educators know they can't use their professional positionsor school property for personal gain, such as selling products or getting free perks from vendors. They know that educators who want to tutor or give private lessons to district students must first seek district approval.

8. **Mandatory Reporting:** Responsible educators know all school workers are mandatory reporters under the law. If they have reasonable suspicion of child abuse or neglect by parents, other educators, or other students or they believe a student is self-harming, they must report it.

9. Physical or Verbal Altercations with Students:

Responsible educators avoid physical and verbal altercations with students by using proper classroom management and de-escalation techniques.

#### 10. Failure to Supervise

Educators are responsible for student safety at all times. Responsible educators review course materials, educational supplements and media, and the school environment before using these materials.
