## **2018-19 OSU Employer Perceptions Survey Results**

In May, a group of Ohio public school principals were surveyed regarding their perceptions of recently hired Ohio State teachers in their buildings. Overall, for the second year in a row, all employers agreed our graduates were adequately prepared in the 15 targeted areas.

Strengths:

- Understanding ***student learning and development*** (Q1)
- Proficiency in their teaching ***content area*** (Q2)
- Creating healthy ***learning environments*** for all students (Q9)
- Promoting the ***use of technology*** to engage students and facilitate learning (Q15)

Areas for Improvement:

- Aligning instructional ***goals to building/district initiatives*** (Q7)
- ***Maintaining a learning environment*** for all students (Q10)
- Assuming responsibility for their own ***professional growth*** (Q14)
