OHIO STANDARDS MODULE AND THE OPIOID POWERPOINT

2018 autumn student teachers will be completing the Ohio Standards for Educator Preparation Course module and the Opioid module IN THEIR CURRENT STATE. No updates to the module will take place until later this summer. Therefore, please inform your **autumn 2018 student teachers** to get both the Ohio Standards module and the Opioid PowerPoint completed **BEFORE July 1**st.

Anyone who does not complete the requirement before July 1st will need to wait for the updates and complete the newer version once it becomes available. The new version is considerably longer than the current one. To view a flyer that may be shared with your students, go <u>here</u>.

RESULTS OF EMPLOYER FOCUS GROUPS AND INTERVIEWS

Principals and HR personnel from 11 school districts were interviewed during the 2017-2018 school year. Results include categories such as Accolades and Areas to Improve.

Among top accolades reported:

- Ohio State hires are high quality, knowledgeable in content and pedagogy, and great at classroom management.
- Ohio State leads the way by having District/Program Manager Meetings.
- OSU students are prepared to make an immediate impact, as shown in OTES scores.
- Possess a high level of knowledge and ways to integrate technology in lessons.

Areas of suggested improvement include:

- Increase providing strategies in communication and developing relationships with students, including how to identify and develop socio-emotional skills in learners.
- Increase the Early Childhood students understanding of special education.

The overall impression of novice teachers from OSU included these quotes:

- "Ohio State develops the most prepared teachers in Ohio as I also do a lot of recruiting for our district. I will do the entire Teach Ohio job fair circuit and as I begin I am disappointed. I might hire 3-5 but when I get to Ohio State it is like 16 out of 18 interviews I am ready to hire."
- "Excellent, OSU is our preferred group of candidates when we have openings."
- "They are aware of all the diversity areas not just race and color but gender equity, ELL, special education, socio-economic."

• "The OSU graduates have always been professional and is one of the things that sets them apart from others."

edTPA UPDATES

edTPA Handbook Improvement Survey

SCALE, the designers and developers of edTPA, regularly seeks feedback from both programs and students for improvements, such as how to make the assessment more user-friendly.

edTPA Focus Group

The December Focus groups for edTPA showed majority support, and recommended it for a licensure requirement *if* it replaces the OAE Professional Knowledge test. While participants expressed concern about the stress candidates experience and the overall cost, they felt the benefits outweighed these. The Chancellor supported the recommendation, and it has been sent to ODE for their action.

edTPA & OAE Scores Posted

The most recent round of edTPA and OAE scores are posted to your Ed Prep program's Buckeye Box. Please check your Data folders for your students' scores.

During the spring 2018 semester, OEP received 338 edTPA scores with the overall average score of 45.0 points. In late-April, we received 182 OAE scores. The overall pass rate was 89% with an 80.7% pass rate for the 090 reading content test.

The next batch of OAE scores will be available on Friday, May 18, from tests taken April 9 to May 6.

ARE YOUR STUDENTS ELIGIBLE FOR LOAN FORGIVENESS OR TEACH GRANTS?

The Federal Teacher Education Assistance for College and Higher Education (TEACH) grant is awarded to students that earn licenses in high need fields and will teach in low income schools. Additionally, students may be eligible for Federal loan forgiveness or deferment. For Ohio 2017-2018, high need fields include:

- AYA Areas: English/language Arts, Mathematics, Science, Social Studies
- Multi-Age: Special Education (all), Visual Arts, TESOL
- Other school professionals: School Psychologist, Speech/Language Pathology
