#### **CAEP REVIEW UPDATE**

We received the preliminary On-Site Summary report from CAEP. This week, we submitted a Fact Check Response, which is a standard process for CAEP. The next step for us will be to submit a formal response called a Rejoinder. We will share that response once it has been finalized. In late spring we expect to receive the final results of the CAEP accreditation visit.

#### **LICENSURE UPDATES**

# **Current Candidates: When to Apply For Licensure**

Program managers, please inform your current candidates to apply to ODE for their license in mid- to late-April. Applications expire after 60 days after they are eligible and candidates cannot be approved until **May 5** (2019 spring graduation). If students are waiting on OAE test scores, they may want to wait to apply for licensure until after receiving their passing score report.

Please encourage your upcoming graduates to apply for their licenses after completion of their program. As program requirements change over time (new courses, OAE tests, etc.), students who wait to apply for licensure are often delayed in obtaining their license until new requirements are met.

# Reminder: Praxis II Tests Will Be "Sunsetting" as of June 2019

The Ohio Department of Education will stop accepting Praxis tests for new licenses in **June 2019**. Ohio State has no rule to limit how long a completer has to apply for a state license. That decision is made at the program level (we send a program sheet for program approval). If you have any completers from 2012 or earlier, encourage them to apply for their license soon.

## Middle Childhood Candidates: Licensing changes coming in 2019

The temporary option for licensing in only one Middle Childhood content area will be closing **July 1, 2019**. Any student applying for a Middle Childhood license on or after this date must be eligible for licensing in **two** content areas in order for the license to be issued.

This temporary option was established in 2013 at the beginning of the implementation of the new middle grades licensure content exams in order to provide transition time to the two content area requirement. Additionally, the middle grades exams have been realigned to the grades 4-9 content. As a result, the option for licensing in only one middle childhood content area will sunset on **June 30, 2019.** 

## **CPAST Training for Student Teaching Supervisors**

As a reminder, student teaching supervisors are required to annually complete and pass a CPAST training in Carmen by **February 1, 2019.** There are two versions – one for new supervisors (approx. 1.5 hours) and a refresher for returners (approx. 30 min). To ensure validity and reliability of the scores, all must take the trainings until they pass the concluding guiz.
