PRAXIS II TESTS WILL NOT BE ACCEPTED BEGINNING JUNE 2019

The Ohio Department of Education will stop accepting Praxis tests for new licenses in June 2019. Ohio State does not limit how long a completer has to apply for a state license. That decision is made at the program level. If you have any completers from 2012 or earlier, please encourage them to apply for their license before this new rule goes into effect.

OEP DATA DAYS

NEW edTPA AND OAE SCORES POSTED

The most recent round of edTPA and OAE scores are posted to your Ed Prep program's Buckeye Box. Please check your data folders for your students' scores.

During the 2017-18 academic year, OEP received 429 edTPA scores with the overall average score of 44.7 points. In late-May, we received 158 OAE scores, 60 of which were the Foundations of Reading test. The overall pass rate was 84.2% with an 83.3% pass rate for the reading content test.

The next batch of OAE scores will be available on Monday, June 18 from tests taken May 7 through June 3.

If your program has candidates who graduated this academic year who have yet to pass all of their OAE required for licensure, please contact them to request retakes by **August 1, 2018**. This timeline will ensure passing scores are reflected in the upcoming Title II report.

edTPA UPDATES

edTPA Student Release Form & 2018-19 Submission and Reporting Dates

The edTPA Student Release Form for the 2018-19 school year has been updated in your program's Buckeye Box. Look in the edTPA Resources > Resources for OSU Faculty > Consent Forms & Attestations folder for the English version with a current date.

If your candidates are required to personally keep these forms per district/school policy, it is each program's responsibility to gather the forms and keep them in your records for **at least two semesters** after the completion of edTPA, per OSU's record retention guidelines. See page 2 of the OSU Candidate Attestation form for a list of the commonly used district policies. It is also posted in the Resources for OSU Faculty folder.

Pearson recently released the submission and reporting dates for the 2018-19 academic year. They can be found online [here](#) and in your edTPA Resources folder.

The deadline to submit is **November 8, 2018** for Autumn 2018 and **March 28, 2019** for Spring 2019 in order to receive scores prior to the end of the term.

BACKGROUND CHECKS – WHAT IF A STUDENT DOESN'T MEET THE STATE REQUIREMENTS?

Please remember, part of the *entrance* to a program is the need to pass both FBI & BCI&I background checks that match the criteria set forth by the screening tool of Ohio Department of Education. It is respectful to the student to assess the background check of candidates *as soon as possible* so students are not taking courses that lead to a licensure in which they are not qualified to obtain.

As a reminder, it is the program's responsibility to notify the student of the reason(s) why they are not eligible to be a part of the program based on this criteria.
