Teacher Employment in Ohio Public Schools

This year, OEP began reporting overall employment rates of initial licensure completers, one of the new annual measures for CAEP. It captures employment in Ohio public schools only, based on records from the Ohio Department of Higher Education.

The top table shows employment data from 2013-14 through 2016-17 school years, and includes the total percent of each licensure cohort employed, percent retained from the previous year, as well as the percent of new teacher hires. This data represents teacher assignments only.
