- 1. Greeting and introductions
- 2. New Business
  - a. Review of meeting minutes from October 2014
  - b. Update on BSEd program enrollment and impact on MEd program (Caroline Clark); Handout #1
    - We have no control over first year enrollment; expect number to grow significantly
    - We do have control over number of Projected Admitted BSEd majors
    - MEd applications for 2015-2016 are expected to decrease significantly from 2014-2015
      - Math and science education programs will have lower numbers due to Woodrow Wilson funding being phased out
      - Math and Science education programs take longer
      - Expecting more applications by February 2015

#### 3. Old Business

- a. Program fees Ad hoc committee update
  - First meeting held on November 24, 2014; next one scheduled for December 8
  - Three lead financial officers will be attending
  - Financial impact and hardship on students was discussed
  - Will be presented to FPA as a package, even though programs have separate fees
  - Harder to bundle some fees, like background checks
- b. OAE pass rates (Handout #2)
  - Front page shows full year of data
  - Our pass rate is acceptable, lower than before but still above state average
  - Some students took test as many as seven times
  - Middle childhood pass rates are a concern in Ohio, in both private and public institutions
  - Standards are grades 9-12, but students are tested on grades 4-12
  - Science and language arts scores are improving
  - Ideas for mid- and long-term fixes
    - Regional campuses could reconsider aligning grades 4-9 content with new semesters (what content knowledge is expected for grades 4-9?)
    - Look at how to help students pass tests, how to navigate before changes come
    - Look at how history and geography are taught in a factual way, not broad areas
    - Art Ed looks at different eras; geography included
    - Perhaps suggest different courses
      - History 151 and 152 were eliminated as requirements; perhaps reinstate
    - Form a group to discuss this (worked well in Woodrow Wilson program)
    - Look at Math as a model

## c. FEEP update (Yvonne Goddard) Handout #3

- Students are placed in public K-12 settings, but hope to expand this
- Course introduces students to the good, the bad and the ugly; some do not continue
- Offers an opportunity to examine belief systems; students are placed in a setting that is opposite of what they had (i.e. a city student would be placed in a suburban setting)
- FEEP is an undergraduate, 3 credit hour general education course; can be used as a service learning course; great opportunity to collaborate with local partners
- STEP Program (second year on-campus residence program) would be a great fit for FEEP as a service learning course
- Remains at 5 credit hours for students in Special Education program
- Students are placed into their area of interest, Art and Music students have a harder time getting all the hours needed
- Students also have on-campus seminars, research-based readings, guest speakers

### d. NCATE visit update

- Third Party Testimony (handout #4)
  - Four colleges and four regional campuses were contacted to advertise the opportunity for third party comments about the university's 47 Ed Prep programs
  - Seven of eight posted articles on websites, newsletters and alumni listserves
  - Deadline for submission is January 15, 2015
- Summary of BOE Chair phone call with Yuhang Rong, Associate Dean, College of Education, University of Connecticut
  - He has a good understanding of larger universities (size and scope)
  - Has a partnership attitude; no surprises, no need to do extra work
  - Focus on basics
  - $\circ~$  Dr. Rong will skype with all regional campuses; no travel time involved
  - Sunday evening poster session will be reserved for programs of concern

#### 4. Discussion/announcements

- a. Randy Smith gave an update on the math committee he serves on with math chairs
  - Group met on December 4, 2014
  - Discussed math pathways (STEM follows this path)
- b. Dean Achterberg discussed the proposed bill to eliminate the "5 of 8" rule, which would cut Art and Music Education, among other areas, in school districts
  - Funds from those programs would be used instead for areas like math and science
  - It would diminish college readiness and increase the achievement gap, among other areas of concern
  - Please send your comments to Dean Achterberg in support of keeping the rule
- c. National Data Initiative Team (Erica Brownstein)
  - Ohio is ahead of the game in the metrics reports for pre-service
  - Federal regulations are just out for pre-service
  - Teachers will be followed for five years after they graduate
  - Volume and support of concerns is critical
