- 1. Greeting and introductions
  - Welcome by Randy Smith
  - Introductions
    - o New attendee Eric Anderman, Chair, Department of Educational Studies
- 2. Old Business
  - Reviewed minutes from February 2014 meeting; submit changes you think are needed
  - Handout *Admission to Program Professional Dispositions Evaluation Rubric* developed from request at last meeting. Rubric is required by state for all programs.
  - Dual Enrollment
    - o Has a positive impact on lower income students
    - Very hot topic at state level; different meaning to each individual
    - o What does it mean to be Dual Enrollment certified?
    - As of March 6, 2014, OSU may not have our instructors teaching at high schools; they need additional resources in terms of Professional Development and class observation
- 3. Gates Subcommittee Report: Admission to Program Gate, Erica Brownstein
  - Review of handout
  - Needs to be endorsed by UTEC
  - Graduate school admission requirements not changing
  - Are career changers evaluated same way?
  - SAT writing requirement changing in 2016; no longer required
  - Pay close attention to semester residence versus credit hours to meet prerequisites for teaching preparation program
  - May vary from one program to next
  - We need to continually revisit
  - Impact on STEM students (10% are in 2.75 3.00 gpa band)
    - Make rule now , bring data and implement for autumn semester, revisit
    - o Encourage STEM students to apply even if close to required gpa
  - Applies to licensure students only
  - Need for roundtable discussion and agreement
- 4. Appeals Subcommittee Discussion
  - Biggest concern is that there needs to be a process in place for conditional admissions and appeals; one that is flexible
  - Students need to be looked at objectively
  - Some of the wording came from the Graduate Appeals Framework
  - Two levels of appeals
    - o Paper, brought forth by individual or program
    - In-person, after paper version, by request of student or department
  - Department does not make final decision; it goes to a higher level

- Accreditation purposes are main reason for this, and need to act uniformly
- Both students and programs can appeal admission decisions
- Some criteria, such as talent (versus entry scores), are critical to address
- Review all documents before next meeting; some wording will be fixed and purpose (NCATE) will be added at top
- Providing a variety of course scenarios would be helpful
- 5. NCATE/CAEP Update
  - Spring of 2015 is next visit by NCATE, 2017 for CAEP
  - NCATE joined with TEAC to form CAEP; there are all new standards with new requirements (ACT scores, etcetera).
  - For CAEP, every key assessment must be scientifically valid and reliable; these are very different from each other
  - We are required to have a minimum of six assessments per program
  - We should collaborate with other campuses; also invite NCATE/CAEP people to come and visit, give advice.
  - We should look at publications from way back for validity and reliability instruments; journals may be a resource.
  - We need to have a brief discussion at every meeting on where we are; monitor our progress every year.
  - We have 176 key assessments; an example is student teaching or lesson plan unique to special education
  - We need to be more data driven with evidence, especially at the program level
- 6. Brief overview of UTEC
  - Started in 2000 as an advisory committee, sharing information for college to bring program back to undergraduate level?????
  - Supplemented this group with Art and Music departments
  - Proposed changes start with UTEC for endorsement, then go to the Council on Academic Affairs
  - A goal of UTEC should be alignment and expediency
